His posts at the National Security Council at the White House from 1988 to 1998, under Presidents George H. W. Bush and William Clinton, included Director for Counter-terrorism and Counter-narcotics, Director for Peacekeeping, and Senior Director for Intelligence Programs. From 1998 to 2003, he was Assistant Secretary of State for International Narcotics and Law Enforcement Affairs, and subsequently served again at the National Security Council as Special Assistant to the President and Senior Director for Combating Terrorism.
